- 1) Discussion on when to put on the ballot., August Sheriffs 2 ballots, CCTA new millage, Veterans November, Road Commission, and the COA.
- 2) The period of how many years, this one state 6 years. We will need to decide how many years.

The new amount would be \$812,056. Which is an increase. Arauco did not file their personal property tax. We received more money than if they filed.

New Sawmill tiff has been approved. In June, we will know if the DDA gets a tiff.

# a. Crawford County Under 60
